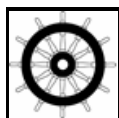

Approved colour: Grey and brighter colours.
Max. organic content: 13.2 %.

Not to be used as an integrated part of a horizontal class A division unless tested as such.

The product may also be used as floor covering in accordance with IMO 2010 FTP Code part 5 Appendix 4 paragraph 4.9.2.

Each product is to be supplied with its manual for installation and use.
