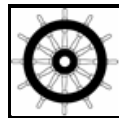

## Product description

"Marlon Poly-Marine"

is a primary deck covering consisting of 1-5 mm mineral rocks (special aggregates) and 1-2 mm PU compound (Marlon Poly-Marine). The PU compound is a three-component polyurethane system consisting of (A) polyol with fillers, additives and pigments, (B) MDI isocyanate hardeners and (C) quartz sand.

Weight: 2-3.5 kg/m<sup>2</sup>  
Maximum thickness: 7 mm

## Application/Limitation

Primary deck covering, not generating excessive quantities of smoke nor toxic products in fire.

The product may be applied over any steel or non-combustible material.

Approved colour: grey and brighter colours  
Max. organic content: 30 %  
Mixing ratio (A:B:C): 4:1:4

Not to be used as an integrated part of horizontal class A division unless tested as such.

The product may also be used as floor covering in accordance with IMO 2010 FTP code Part 5 appendix 4 paragraph 4.9.2.

Each product is to be supplied with its manual for installation, use and maintenance.
