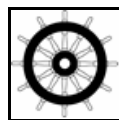

Product description

“Class A-60 Marine sound floor -steel”

Composed of structural steel deck covered with Class A-60 Marine Sound Floor – Steel. The floating floor is constructed from bottom to top as follows:

1. One layer of min. 50 mm thick Rockwool SeaRox SL 436 manufactured by Rockwool (density 140 kg/m³).
2. One layer of 3 mm thick steel plates.
3. One layer of 1 mm thick Marine VE 1400 (density 1350 kg/m³).
4. One layer of 2 mm thick steel plates.

Application/Limitation

Approved for use as a horizontal fire retarding steel division of class A-60.

The insulation materials, viscoelastic damping layer and adhesives used must be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation, use and maintenance.
