### **Product description**

"Marine VE 1400 - Concrete"

Primary deck covering consisting of:

- one layer (first layer) of 1 mm 2 mm thick "Marine VE 1400", a viscoelastic damping layer composed of a twocomponent polyurethane compound with nominel density of 1.350 kg/m³, and
- 2. one layer (top layer) of 10 mm 30 mm thick "Marine 1600 SL" composed of inorganic filler and synthetic polymers with nominel density 1.600 kg/m<sup>3</sup>.

Maximum thickness: 32 mm

## Application/Limitation

Primary deck covering, not generating excessive quantities of smoke nor toxic products in fire.

The product may also be used as floor covering in accordance with IMO 2010 FTP code part 5 appendix 4 paragraph 4.9.2.

The product may be applied over any steel or non-combustible material.
